Abstract

All articles must contain an abstract. Content in abstract should be written with the Font style: Calibri; Font size: 12; Paragraph: Justify; Line spacing: 1.0. Insert two spacing after the abstract before you begin the main text of your article, starting on the same page as the abstract. The abstract should give readers concise information about the content of the article and indicate a short introduction of background study, purpose of the study, briefing about the used method, principal results and major conclusions. The abstract is not part of the text and should be complete in itself; no table numbers, figure numbers, references or displayed mathematical expressions should be included. It should be suitable for direct inclusion in abstracting services and should not exceed 250 words in a single paragraph. Since contemporary information-retrieval systems rely heavily on the content of titles and abstracts to identify relevant articles in literature searches, great care should be taken in constructing both.

1. Paragraph

The subsequent paragraphs should be indented by 0.63cm (no spacing between paragraphs). Content in body paragraph should be written with the Font style: Calibri; Font size: 12; Paragraph: Justify; Line spacing: 1.0.

Header level three (1.1.1) and above will follow header level three style. No spacing between each header. However, before starting the first paragraph, must have one spacing after the header.

In the last paragraph of introduction section, Authors should highlight the gap and significant of the research before write the objective of the research. These three items are very important and compulsory.

1.1 Figure Style and Format

For manuscript publication, all provided Figures must follow the standard of quality for publication. Authors must provide a high quality with high resolution Figure. Content in the Figure should be clear and readable. Each Figure must be discussed or mentioned in a body paragraph. The Figure must be placed under the paragraph that discussed about the Figure.

Captions should be below the figure. The caption SHOULD NOT be finished with a full stop (period). Figures should be numbered sequentially through the text— 'Figure 1', 'Figure 2' and so forth and should be referenced in the text as 'Figure 1', 'Figure 2'... and not 'Fig. 1', 'Fig. 2'.

1.1.1 Table style and format

Table should be placed at the centre unless they occupy the full width of the text. Each Table must be discussed or mentioned in a body paragraph. The Table must be placed under the paragraph that discussed about the Table. Content in the Table should be written with the Font style: Calibri; Font size: 10. The content must be aligned left. Table caption should be written with the Font style: Calibri; Font size: 11. The caption SHOULD NOT be finished with a full stop (period). The captions should be set to the width or within of the Table.

The list of references should only include works that are cited in the text and that have been published or accepted for publication. Personal communications and unpublished works should only be mentioned in the text. Reference style should be in APA style. Citation of the references should be write using author name system (Rosly *et al.*, 2020).
